**Terms & Conditions of Sale**

As official tyre service provider for the British Superbike Championships in categories Superbike, Supersport, Superstock 1000 & Superstock 600, Triumph Triple Challenge and the Ducati 848 Challenge, the following terms & conditions apply:

- Payment for all tyres is the responsibility of the person who signs at the bottom of this form.
- Please pre order and pay for your required tyres prior to the event. Your tyres will be available to collect from the Pirelli/Metzeler race service. Any additional tyres that you require are to be paid in full at the event.
- Whichever method of payment is preferred; the condition is that all accounts are to be **settled in full before the event**. Failure to do so could result in your tyre supply being suspended until the outstanding balance is settled. Any accounts outstanding at the start of the following round will be subjected to an additional charge of 1% interest per day. Any extra tyres purchased at the event must be paid for in full at the time of collection.
- **Cash payments** will be accepted at the time of purchase & a receipt will be given at the event. After the race an invoice will be raised & emailed to each payee within the following week.
- **Cheque payments** will be accepted however they must be cleared before the event.
- **Debit Card payments** Competition Logistics Ltd will require card details including expiry & or start date, issue number & security number if applicable. All debit card details will be held by Competition Logistics Ltd. For any card detail changes, for example, change of expiry date, issue number or a different card to be used, Competition Logistics Ltd must be informed. Then an additional rider registration form must be completed in full and signed. **Debit cards do not have any additional charge.**
- **Credit Card payments** Competition Logistics Ltd will require card details including expiry & or start date, issue number & security number if applicable. All credit card details will be held by Competition Logistics Ltd. For any card detail changes, for example, change of expiry date, issue number or a different card to be used, Competition Logistics Ltd must be informed. Then an additional rider registration form must be completed in full and signed. **All Credit cards will have an additional charge of 2% on every transaction.**
- **CHAPS/BACS payments** must be received before the event. Competition Logistics must be notified clearly when CHAPS or BACS payments are going to be used. There must be a reference to the invoice number and the Team or Rider name on each transaction. Competition Logistics bank details are shown on this document.
- Each team/rider is required to complete the tyre registration form with main emphasis on the person directly responsible for payment. This undertaking is mandatory. Competition Logistics Ltd must be informed of any changes of circumstances & approve such

changes. Any team/rider who has defaulted payments in the past may be asked for payment by card or cash in advance at each event. Full contact details for invoice payee are required.

- For any payments to be made at the event a mobile card machine is available.
- Remember if there are any changes to the team regarding riders, Competition Logistics Ltd must be informed and an additional rider registration form must be completed in full and signed.

**Terms & Conditions Of Tyres**

To assist with the smooth running of the tyre fitment racing service we respectfully ask that all teams/riders follow the guidelines below.

- Wheels to be presented clean.
- All detachable spacers & sprockets removed.
- Wheels to be identified by team/riders number/name & rotation arrow.
- Deflated & presented without valve core/cap.
- Old balance weights removed.
- Old tyres to be marked with identification.
- Old tyres to be taken when wheels collected (if required).
- Old tyres left at the end of the day will be considered as scrap.

Competition Logistics Ltd cannot be held responsible for customers wheels if they are not clearly marked as suggested above.

New valve cores will be fitted every time. Please keep hold of valve caps. Competition Logistics Ltd will supply metal caps when required (always use sealed metal caps). All tyres will be inflated to 2.5 bar. Pressures must be checked by the team/rider. There will an additional charge for angled valves.

As I am sure you will realise, it will be a very busy time & all help & consideration will be much appreciated not only by Competition Logistics Ltd but also fellow competitors by cutting waiting time to a minimum.
